Section I: Noyce Scholarship Program Requirements:

- Completion of the teaching certification program is required within two (2) years of receipt of the scholarship.
- **Undergraduate recipients** are required to complete two (2) years, per year of scholarship received, teaching mathematics or science in a high need school district, preferably in Washington State. Teaching requirement is to be completed within six (6) years after graduation or completion of the scholarship program eligibility.
- **Graduate recipients** are required to complete two (2) years teaching mathematics or science in a high need school district, preferably in Washington State within six (6) years after graduation or completion of the scholarship program eligibility.
- The borrower is entitled to have up to 100% of this loan canceled if the borrower undertakes service as a fulltime, certified mathematics, science or computer science teacher in a “high-need local educational agency” as defined by the Seattle Pacific University Robert Noyce Scholarship Program. This loan will be canceled according to the following schedule:

- Recipients are to provide to SPU certification of employment at the beginning and end of each academic year, which may include a letter from a school supervisor verifying employment, or a copy of recipient’s teaching contract.
