

### Perkins Center Writing Honoring Dr. John M. Perkins



The Perkins Center Prize honors Dr. John M. Perkins and the indelible mark he has made on the work of reconciliation and Christian Community Development. With generous support from our community, the John Perkins Center is hosting this scholarship competition to encourage current and future Seattle Pacific University students to explore practical ways to promote reconciliation.

### **PRIZE DESCRIPTIONS**

Up to two finalist may be chosen from among the entries received. Each eligible finalists will receive a tuition scholarship to Seattle Pacific University.

First Prize: \$2,000

Second Prize: \$1,000

### **ELIGIBILITY**

- The competition is open to:
  - -Current Seattle Pacific University undergraduate students who will be enrolled at SPU in the 2024-2025 academic year.
  - -High school students and transfer students who will be enrolled at SPU in the 2024-2025 academic year.
- Entrants must be enrolled full time (12+ credits) each quarter (fall, winter, and spring quarters).
- The scholarship will be divided over the three main school year quarters (fall, winter, and spring).
- Entrants who receive a prize but withdraw from SPU or fail to matriculate in the next academic year will forfeit the scholarship.
- Entries must be original works by the entrants and must not infringe copyright or proprietary right of any other person.
- One person per entry.
- Entries must include completed Perkins Center Prize entry form (including parental/guardian signature for minors).
- Entrants must give the John Perkins Center and SPU consent to publish and use the submission.
- Winners will be presented in April of 2024 during the JPC Spring lecture series.



# Perkins Center Writing Honoring Dr. John M. Perkins PRIZE

### Who is John Perkins?

The Perkins Center has grounded itself within Dr. Perkins 3 R's, which presents a particular approach to community engagement. Dr. John M. Perkins, an American Christian minister, civil rights leader, and author, developed an international practice of community engagement that began as the 3 R's and grew into a set of 8 Christian Community Development principles. Born in 1930 in Jackson, Mississippi, his story emerged out of economic and racial injustice in our country that impassioned his work towards cultivating reconciliation within our communities; working across economic, racial, and socio-cultural barriers. He is the founder and President Emeritus of the John & Vera Mae Perkins Foundation with his wife, Vera Mae Perkins; and co-founder of the Christian Community Development Association (CCDA). In 2004, Seattle Pacific embarked into a university partnership with the Perkins Foundation, resulting in the John Perkins Center who serves at the place of intersection and connection between campus and the Seattle regional community.

### The 3 R's

### **Relocation: Living Among the People**

Living out the gospel through relocation means desiring for one's neighbor and neighbor's family that which one desires for one's self and family. It means bettering the quality of other people's lives spiritually, physically, socially, and emotionally as you would do for your own, even sharing in the suffering and pain of others. By relocating into a community and becoming a neighbor, solutions begin to transform from a "you, them, theirs" perspective and understanding, into a "we, us, ours".

### Reconciliation: People to God and People to People

Reconciliation is at the core of the gospel and is often summed up in the two commandments from Mathew: Love God and Love thy neighbor. Reconciliation helps to look at Christian discipleship in reconciling people to God and reconciling people to people. It works in building relationships, partnering and working together across social and cultural barriers to work for justice for the entire community.

### **Redistribution: A Just Distribution of Resources**

Being a good neighbor is working towards justice for the entire community and utilizing resources along the way. The redistribution principle is more than economics and is about empowering residence of a community to creatively engage in long-term development, in order to bring about healthy transformation. Redistribution is a look at equity and access, bringing skills, relationships, opportunities, and resources together and pursuing them at work.

### **WRITING PROMPTS**

The writing prompts below are intended to help entrants focus their writing:

- Describe/express how the principles of Relocation, Reconciliation, and Redistribution can address the current racial climate that exists in the United States of America. As part of your answer, please consider issues that would need to be addressed to successfully establish/practice these principles.
- Develop a program that can be implemented to address a particular social issue using Christian Community Development
  Association principles or foundations from Dr. Perkins' teachings and books. Your program should be something that could plausibly be implemented by the church, student organizations, or another community organization to which you are particularly connected.
- Produce new research into a particular social issue or social concern that the church, public/private institutions, or organizations you are connected to have not fully addressed. Describe how you would go about being the change agent or catalyst to bring about reconciliation, justice, and leadership development.

### **ENTRY CRITERIA**

Writing Type: written entries may take essay form, research paper form or a story form.

- Writing length should not exceed 2,000 words.
- Entries must be written by the entrant and be original work.
- Quotations and facts that are not common knowledge should include proper citations.

### Judging Criteria:

- Entries must focus on a social justice topic or issue by clearly communicating an answer to one of the above prompts.
- Entries will be judged based on creativity, originality, and/or the potential for the findings or program to be utilized and implemented.

### **SUBMISSION INSTRUCTIONS**

- Entries must be emailed or postmarked by Monday, April 3rd, 2024
- Scholarship recipients will be notified by the 17th of April, and requested to attend the ceremony for award during the Annual Perkins Lecture Series.
- PLEASE NOTE: If you are a first or second place winner of this competition, you will be asked to create a poster highlighting the key points of your paper to be on display in the entree way at the Perkins Lecture Series, April 23rd, 2024.
- Please include/attach the entry form and a high-resolution picture of yourself (for presentation purposes).
